ORDER UNDER SECTION 144 OF Cr. Pc

Whereas, a meeting of G-20 Nations is scheduled at Dharamshala on 19th and 20th April, 2023 wherein dignitaries/VVIPs from various parts of the Globe will participate;

Whereas, the activities like paragliding, drone flying, hot air balloons and other activities of aero sports/airborne activities may create issues for the overall safety and security of the National/International dignitaries participating in G-20 event;


Whereas, I am of the view that in order to ensure safety and security of the dignitaries visiting District Kangra, it is essential to prohibit each activity related to aero sports/airborne activities or drone flying and that there is sufficient ground available to proceed under section 144 of the Cr. Pc. to prohibit these activities and given the circumstances, it is not possible to serve this notice upon all the persons residing in District Kangra and accordingly, the order needs to be passed ex-parte as per section 144 (2) ibid;

Therefore, I, Dr. Nipun Jindal, District Magistrate, Kangra at Dharamshala in exercise of the powers vested in me under section 144 of Cr. Pc. do hereby order and direct that all activities related to paragliding, drone flying, hot air balloons and other activities of aero sports/airborne activities shall remain prohibited from 12 P.M. onwards on 18th April, 2023 till midnight of 20th April, 2023, within the administrative boundaries of Sub Division Dharamshala, and Kangra except:-

- a) flying of drones by the personnel's deputed for the security and maintenance of Law and Order during the event for the purpose of surveillance subject to the approval from competent authority.

Any person/authority/organisation found violating the aforesaid directions shall attract appropriate action under section 188 of IPC.
