Order under section 28 and 33 of Disaster Management Act, 2005

Whereas, on dated 02 September, 2022 a devastating cloud burst hit at Ghurlu Nala, resulted in injury to one child and damage to the private infrastructure and land of Khaniyara, Dharamshala;

Whereas, the undersigned has received a representation from the residents of the affected area stating that in absence of the mitigation measures undertaken for flood protection in the affected area there is a risk of loss to life and property during upcoming monsoon season;

Whereas, I am of the view that there is a dire need to conduct a technical investigation of the flood affected site and implement required mitigation measures to ensure the safety of the local residents;

Therefore, I, Dr. Nipun Jindal, District Magistrate- cum- Chairperson, District Disaster Management Authority in exercise of the powers vested in me under section 28 and 30 of the Disaster Management Act, 2005 and in safety of the public at large do hereby notify an site investigation committee as under:-

1. Sub Divisional Magistrate, Dharamshala (Chairperson)
2. Additional Municipal Commissioner, Dharamshala (Member)
3. Executive Engineer, HPPWD, Dharamshala, (Member)
4. Executive Engineer, Jal Shakti Vibhag, Dharamshala, (Member)
5. Divisional Forest Officer, Dharamshala (Member)
6. Tehsildar Dharamshala, (Member)
7. Block Development Officer, Dharamshala, (Member)

and the aforementioned committee shall:-

1. Conduct a site visit of affected site near Ghurlu Nala, Khaniyara for detailed site investigation
2. prepare and submit a report suggesting remedial/mitigation measures required to safeguard the residents/infrastructure at Khaniyara from flooding in Ghurlu Nala within 10 days of issuance of this order


