

### ORDER UNDER SECTION 34 OF THE DISASTER MANAGEMENT ACT- 2005

In continuation to this office order no. 21 SK/DM, Dated 10<sup>th</sup> January, 2022 and in compliance to the directions passed by the Chief Secretary- cum- Chairperson, State Executive Committee, Himachal Pradesh vide order no. Rev (DMC) (C) 20-2/2021- COVID 19-IV, Dated 13<sup>th</sup> January, 2022, I, Dr. Nipun Jindal, District Magistrate, Kangra at Dharamshala in exercise of the power vested in me under section 34 of the Disaster Management Act- 2005 and in welfare of the public at large do hereby order and direct that:

- Persons with disabilities and pregnant women employees shall be exempted from attending office but required to work from home.

This order shall remain in force in all parts of the District till 06:00 A.M. of 24<sup>th</sup> January, 2022 or further orders, whichever is earlier.



**ORDER**

Whereas, orders of even number dated 05-01-2022, 08-01-2022 and 09-01-2022 were issued by the State Executive Committee (SEC) for effective control of COVID19 in the State.

Whereas, considering the recent surge in COVID-19 cases across the State and after considering the current situation of the COVID-19 pandemic which requires strict measures in order to contain its spread.

Therefore, in exercise of the powers conferred under the Section 22(2)(h) and Section 24 of the Disaster Management Act 2005, the undersigned in the capacity of the Chairman, State Executive Committee (SEC), hereby directs that the following exemption shall be in force in addition to the directions already issued by SEC vide order dated 05-01-2022, 08-01-2022 and 09-01-2022 in Himachal Pradesh:

- **Persons with disabilities and pregnant women employees shall be exempted from attending office but are required to work from home.**

This Order shall remain in force, in all parts of the State with immediate effect till 6AM of 24<sup>th</sup> January 2022 or further orders, whichever is earlier.
