

UNDER SECTION 34 OF THE DISASTER MANAGEMENT ACT 2005

In compliance to the directions passed by the Chief Secretary-cum-Chairperson, State Executive Committee, Himachal Pradesh vide order no. Rev (DMC) (C) 20-2/2022- COVID19-IV, Dated 31/01/2022 and considering the present situation of Covid-19 in the District Kangra and in welfare of the public at large, I, Dr.Nipun Jindal, Chairman, District Disaster Management Authority-cum-District Magistrate, Kangra in exercise of the powers vested in me under section 34 of the Disaster Management Act-2005 do hereby order and direct that:-


1. 'No Mask, No Service' policy shall remain operational in the District.
2. Night Curfew from 10 PM to 5 AM shall continue in the District.
3. Classes from 9th to 12th are allowed to function w.e.f. 03.02.2022 in all summer closing schools including residential schools (Government/Semi-Government/Private) operating within the jurisdiction of District Kangra. All other classes shall continue to remain closed. The School administration will ensure observance of the COVID-19 SOPs and safety protocols while conducting the classes.
4. Universities/Colleges/Technical Education and other higher educational institutions are also allowed to open from 03.02.2022 with strict observance of COVID-19 appropriate behavior and safety protocols.
5. All Coaching Centers & Libraries are allowed to open subject to compliance with COVID appropriate behavior and safety protocols.
6. All social/ religious/ academic/ sports/ entertainment/ cultural/ political and other congregations including marriages & funerals are permitted up to 50% of the capacity, subject to maximum of 100 persons in indoor built up/covered areas (whichever is lower). In open spaces/outdoor areas these gatherings are permitted up to 50% of the capacity, subject to maximum of 300 persons (whichever is lower). The organizers of the aforesaid gatherings shall ensure strict observance of COVID-19 appropriate behavior and safety protocols.
7. There shall be no restrictions of capacity and working days in the offices of Government Departments/PSUs/ local bodies/ Autonomous Bodies and they shall function with 100% attendance on all working days. However, persons with disabilities and pregnant women employees shall continue to work from home.
8. Gymnasiums/ Sports Complex and Clubs are allowed to function with strict adherence to the COVID safety protocols.
9. The shops shall open as per their normal prescribed times.
10. Religious *langars* shall remain prohibited in all religious places.

Compliance to this order shall be ensured by the Superintendent of Police, Kangra, all Sub Divisional Magistrates, Kangra, Chief Medical Officer, Kangra, all Executive Magistrates, Kangra, all Block Medical Officers, Kangra, and public at large. Violation of this order shall attract provisions of section 51-60 of Disaster Management Act, 2005 and the violator shall be prosecuted accordingly.


