ORDER UNDER DISASTER MANAGEMENT ACT, 2005

Whereas the undersigned vide order no. 663-SK/DM, dated 18/07/2023 and 698 SK/DM, dated 01/08/2023 had granted conditional authorization to the competent authorities of the Public Works Department and HPSEBL for the utilization of the machinery/ vehicles under circumstances of emergency or disaster that has been discontinued by the HP Public Works Department and HPSEBL consequent to the enforcement of Rule 52 A of the Central Motor Vehicles (First Amendment) Rules, 2023;

Whereas, Superintending Engineer, 5TH Circle, HPPWD, Palampur vide letter no. 7285-86, dated 22/08/2023 has shared details of the JCB No. 53-4320 pertaining to Division Bhawarna which has not been included in the aforementioned previous orders and requested to permit the utilization of the same under circumstances of emergency or disaster;

Therefore, I, Dr. Nipun Jindal, IAS, District Magistrate-cum-Chairman of the District Disaster Management Authority (DDMA), Kangra acting in accordance with the statutory provisions of the Disaster Management Act, 2005, do hereby grant authorization to Superintending Engineer, 5TH Circle, HPPWD, Palampur to utilize the said machinery/equipment in addition to the already notified list of vehicles authorized to be used in order mentioned ibid, subject, to the proviso that the said vehicles/machineries are in a state of optimal working order and pose no risk to human life.

The rest of the terms and conditions of the order shall remain the same.
