ORDER UNDER DISASTER MANAGEMENT ACT, 2005


WHEREAS, the undersigned has been apprised that the utilization of machinery/vehicles imperative for the mitigation of the disaster's impact has been temporarily discontinued by the HP Public Works Department and Himachal Pradesh State Electricity Board Limited in District Kangra consequent to the enforcement of Rule 52 A of the Central Motor Vehicles (First Amendment) Rules, 2023;

WHEREAS, the Department of Public Works and HPSEBL has duly furnished the comprehensive particulars of vehicles/machineries that are in a state of commendable operational efficiency, thereby rendering them capable of being effectively employed during exigencies with a view to expediting the restoration process. The detailed enumeration of the aforementioned vehicles/machineries is encapsulated as **Annexure-1**;

WHEREAS, the Public Works Department and HPSEBL has also informed the undersigned that the services of the said vehicles are urgently required for restoration and maintenance works of the essential public services in this monsoon and they have requested for the urgent deployment of the said assets in dire public interest;

THEREFORE, considering the recent heavy rainfall and the resulting significant damage to public infrastructure, including multiple road obstructions caused by landslides and flash floods within the district, I, Dr. Nipun Jindal, IAS, District Magistrate and Chairman of the District Disaster Management Authority (DDMA), Kangra, hereby grant authorization to the competent authorities of the Public Works Department and HPSEBL to utilize the machinery/vehicles listed in Annexure-1 in emergency or disaster situations. The purpose of this authorization is to facilitate the prompt

restoration of the affected areas, with the condition that the machinery/vehicles are maintained in optimal working order and pose no risk to human life. This order is issued to prioritize public welfare and safety, aiming to ensure a timely and effective response to emergencies and disasters. The Public Works Department and HPSEBL shall be responsible for using the authorized machinery/vehicles in accordance with the aforementioned conditions and in compliance with existing laws and regulations. It should be noted that this order will remain in effect until the completion of the Monsoon Season, specifically until September 15, 2023.






It is therefore, requested to accord the permission to use these vehicles for maintaining the breakdowns in Monsoon Season as well as coming Autumn Season at the earliest please.
