**ORDER UNDER SECTION 31, 33 AND 34 OF THE  
DISASTER MANAGEMENT ACT, 2005**

Whereas, the Hon'ble President of India has been scheduled to visit district Kangra on dated 06/05/2024 and therefore there is need to take preventive measures to ensure safety and security during the above said visit;

Whereas, number of dignitaries/VVIP are expected to be present in the district during the aforesaid visit and therefore the Circuit House, Dharamshala has to be properly secured and prepared if required for the purpose of stay or rest of dignitaries/ VVIP;

Whereas, the undersigned has been apprised by the Nodal Officer, Circuit House that there is a Gas Godown near the circuit house and any untoward incident of fire related hazard may lead to a major disastrous situation putting risk to the dignitaries/VVIPs;

Whereas, I am of the view that in order to ensure safety and security of VVIPs/Dignitaries and general public visiting district Kangra during the scheduled visit of Hon'ble President of India there is a dire need to vacate the Gas Godown near the Circuit House Dharamshala;


Therefore, I, Hemraj Bairwa, District Magistrate, Kangra at Dharamshala in exercise of the powers vested in me under section 31, 33 and 34 of the Disaster Management Act, 2005 and in order to ensure the safety of the public at large, do hereby order and direct that:

1. The Sub Divisional Magistrate, Dharamshala shall ensure to vacate the Gas Godown located near Circuit House Dharamshala with assistance of Nodal Officer, Circuit House with immediate effect.
2. District Controller, Food and Supply, Kangra shall extend all necessary assistance and support to Sub Divisional Magistrate, Dharamshala to ensure the compliance to the direction issued vide point no. 1 of this order.

Compliance to this order shall be ensured by the Sub Divisional Magistrate, Dharamshala, Nodal Officer Circuit House appointed for the



visit of Hon'ble President of India and District Controller, Food and Civil Supply, Kangra.
